Notification of marginal bid in the technology neutral tendering - PLEASE RESPOND TO THE DANISH ENERGY AGENCY BEFORE [DATE]

The Danish Energy Agency has received a bid with a bid price of *[insert the offered bid price]* øre/kWh for installation of *[insert technology]* of *[insert capacity covered by bid]* kW submitted on behalf of *[name and registration no. of tenderer]* in the 2021 technology neutral tendering round (see the publicly available tendering documents).

The Danish Energy Agency has evaluated the bids received. The bids have been evaluated on the basis of the award criterion "lowest offered bid price", evaluated on the basis of the size of the bid price offered in øre/kWh covering electricity production for 20 years from the time of grid connection, see clause 6 of the tender conditions.

After having evaluated the tenders, the Danish Energy Agency has assessed that *[insert name of tenderer]*'s tender is the marginal bid, see clause 6.3 in the tender conditions. This means that the capacity limit or the 90 % threshold is not able to accommodate *[insert name of tenderer]*'s bid for all the capacity offered and that *[insert name of tenderer]* must accept downscaling the offered capacity as a condition to be awarded a contract.
