It is absolutely crucial for everyone to understand that the laws of Physics do not provide for "free lunches", so that everyone has to be aware that at distances of 1km or even 1,5km the prevailing weather conditions play havoc with all measurements. The slightest breeze will influence results, so that it would be essential for all the manufacturer tests to be done at the same time if the comparison were to be meaningful. The user test described in section 1.2 of the Enclosure 2 - tender evaluation model is not very specific or precise when it comes to defining what is meant by e.g. "It will be regarded as positive that the battle noises made for the speaker are experienced as realistic as possible" and in terms as we ask you to define (if possible) in the questions above.</p>
