1. Clause 1 - Information to the Tenderer: The Contracting Authority's collection and processing of personal data

In connection with the tender procedure, the Contracting Authority expects to receive personal data from the tenderer. This is mainly due to the tenderers having to submit information of tenderers contact persons and key employees in connection with the submission of tender

The purpose of this document is to ensure that persons who are the subject of the Contracting Authority's procession of information are notified thereof. Such obligation to notify follows from the provisions of the EU General Data Protection Regulation ("GDPR") and the Danish Supplementary Data Protection Act.

In order to ensure that this obligation is complied with, the tenderer is obliged to do the following:

- Provide all persons whose personal data (pursuant to article 4 of the GDPR) are included in the tender documentation with the information stated in clause 2 ("Notification of processing of personal data in connection with a tender procedure").

2. Clause 2: Notification of processing of personal data in connection with a tender procedure - Purpose of the processing

The Contracting Authority is obliged to follow the rules set out in the Danish Public Procurement Act (Art. No. 14564 of 15 December 2015). The tender procedure is conducted in accordance with Title I and II of the Act.

In connection with the tenderer's submission of tender, the Contracting Authority has collected certain data about you. The data are personal data provided in CV's submitted as part of the tender.

Pursuant to the GDPR and The Danish Supplementary Data Protection Act, the Contracting Authority is the data controller on connection with our processing of your data.

The purpose of the processing of data about you is to evaluate to which tenderer the contract put up for tender is to be awarded. The legal basis for the processing of your personal data is the performance of a task carried out in the public interest or in exercise of official authority vested in the Contracting Authority following the EU General Data Protection Regulation ("GDPR"), art. 6 (1)(c) and (e).

The Contracting Authority only processes data about you that the tenderer has submitted in connection with the submission of tender.

The Contracting Authority will process your data until the data are filed or discarded pursuant to the rules of the Danish Archives Act (Consolidated Act nr. 1201 of 28 September 2016).

The Contracting Authority will entrust your data with the members of the tenderer committee as well as with its external consultants, e.g., in connection with legal assistance and/or assistance with the evaluation of the tenders, and the Contracting Authority may furthermore disclose your data appeals authorities.

3. Your rights

Pursuant to article 15 of the GDPR you are as a general rule entitled to be given access to our processing of your data. This means that you may request that we provide you with information on our processing of your data.

Pursuant to article 21 of the GDPR, you are furthermore entitled to object to our processing of your data. If so, the Contracting Authority will decide whether your objection is justified. If this is the case, the Contracting Authority may no longer process the data in question.

Finally, you are entitled to rectification, erasure or restriction of processing of any data which turn out to be inaccurate or misleading or, in a similar manner, processed in breach of the law. This is set out in article 16–18 and 21 of the GDPR.

If you wish to use your rights under the Act on Personal Data, you must contact the Contracting Authority or the DPO of the Contracting Authority via the abovementioned contact information.

4. Complaints

Any complaints regarding our processing of your data may be lodged with the Danish Data Protection Agency (Datatilsynet) pursuant to article 77 of the GDPR.
